# Be Smart – A Guide to Safer Paddling Know Your Limits!

<u>Be Honest with yourself</u> – Good paddlers know their limits. If you don't feel comfortable in a given set of conditions, return to shore.

<u>The Right Boat for the Conditions</u> – Most kayaks, canoes and SUP's are designed for use on protected waters and moderate currents. Specialized boats are used for whitewater, surf and exposed lakes and oceans. Know the capabilities of your craft. These venues require additional training. <u>Explore Your Limits Safely</u> – Improving your skills is one of the joys of paddling. Practice in safe conditions with instructors or expert paddlers to expand your personal comfort zone.

<u>Impairment - Accidents</u> – Do not go paddling if you should not be driving. Drinks and drugs are even more hazardous on the water. Coast Guard and NYS BUI laws apply to all vessels, which includes recreational canoes, kayaks and SUP's.

### **Boat Safety Facts - PFDs**

- Buy your own life jacket, and wear it.
- Look at the label for size and weight limitations.
- Try it on and check the fit.
- Make sure the life jacket is Coast Guard approved.
- Replace your life jacket if you find air leakage, mildew or rot.
- Never alter a life jacket.
- Check your life jackets yearly for flotation and fit.

### **PFD Quiz**

- 1) You can tell a PFD is Coast Guard approved because it:
