### BOATING SAFETY FATALITY STATISTICS FOR 2005

In the last issue of Soundings, I summarized the results of a study that addressed the issue of under-reporting boating accidents. Boating accident data is collected in the Boating Accident Report Database (BARD) and published by the United State Coast Guard (USCG). Among the three reported categories of (1) fatal injuries, (2) non-fatal, hospital-admitted injuries;

and (3) non-fatal, non-admitted injuries, the most accurate category by far was the fatal injuries with only a 1% underreporting. In this issue of Soundings, the fatal accident data for 2005 are summarized.

Boating Statistics - 2005, issued by the USCG, contains statistics on registered boats and recreational boating accidents along with information on boating safety activities for calendar year 2005. The report is about 50 pages in length and contains numerous tables and graphs that look at boating accident data in many different ways. There are data for fatalities, injuries, and accidents. These data are sorted and categorized by different characteristics such as type of vessel, factors contributing to the accident, whether a personnel flotation device (PDF) was worn or not, and the level of boating instruction, just to name a few. The following is a small sample of the information presented in the report.

Excerpts from the Executive Summary

These results, dealing mainly with boating fatalities, were part of the Executive Summary:

- In 2005, States and jurisdictions reported a total of 12,942,414, registered recreational boats. The 4,969 boating accidents reported in 2005 resulted in 697 fatalities.
- Approximately 70% of all fatal boating accident victims drowned (491 out of 697). Moreover, 87% percent of the victims who drowned were not wearing their personal floatation device (PFD or lifejacket). Overall, fatal accident data show approximately 426 lives could have been saved last year if boaters had worn their lifejackets.
- The most reported type of accident was a collision with another vessel. However, capsizing and falls overboard are the most reported types of fatal accidents and accounted for the vast majority (59%) of all boating fatalities. Boat operators need to pay attention to the capacity label on their

- boat and be careful not to overload small boats (less than 16 feet) with passengers and/or gear.
- Over all, careless/reckless operation, operator inattention, excessive speed and operator inexperience are the leading contributing factors of all reported accidents.
- Twenty-one (21) children age 12 and under lost their lives while boating in 2005 compared to 14 children in 2004.
- Approximately 70% of all reported fatalities occurred on boats where the operator had not received boating safety instruction.
- Alcohol use was either a direct or indirect contributing factor in approximately one-quarter of all boating fatalities in 2005.
- The Executive Summary also contained the following tables.

#### Overall Fatality Rate from 1991 to Present

The report also contained a table showing the overall fatality rate per 100,000 registered boats from 1991 to present. The fatality rate has significantly declined from 8.3 in 1991 to 5.4 in 2005. Most of the decline occurred in the first 8 or 9 years of this period. There has been little change in the rate over the last few years.

# Top International and National Swimmers to Swim in Lake George Marathon

Three marathon swimmers from Argentina and several top marathon swimmers from the U.S. have contacted Race Chairman, Graham Bailey, indicating their intent to compete in the 41 k (25-mile) open water swim in Lake George, N.Y. on June 30, 2007.

Twenty top professional swimmers will compete for a total prize purse of \$25,000. The starting gun will be fired at 8:00 a.m. on Saturday morning at Shepherds Park in Lake George Village, the swimmers will proceed along the western shore of the lake to the finish at The Hague Town Beach, approximately 8 – 10 hours later. This marquis event will commemorate the 80<sup>th</sup> anniversary of the original Lake George Swim Marathon that was held in 1927.

Shorter open water swim events will be held on Saturday in Lake George Village and on Sunday in Bolton Landing and Hague. Medals will be awarded to the first 3 finishers in each age group. There has been much interest already in these shorter water swim events from both local and national swimmers.

The Lake George Open Water Swim, planned by Swim Lake George Association, will be hosted by the Glens Falls YMCA Gators and Sanctioned by USA Swimming and U.S. Masters Swimming. During the next few months, the Association will be seeking sponsors and volunteers to help make this a truly spectacular event which will be repeated on an annual basis.
