## BOATING SAFETY

### CARBON MONOXIDE – A TOXIC GAS

Carbon monoxide is a colorless, odorless, tasteless gas that is produced by the incomplete combustion of fossil fuels. It is also toxic which makes it a boating safety issue. Sources on your boat may include engines, gas generators, cooking ranges, and space and water heaters.

Carbon monoxide (CO) enters your body through the lungs and interferes with the distribution of oxygen in the blood to the rest of the body. Symptoms of CO poisoning include headache, nausea, weakness, confusion, disorientation, and dizziness. Early symptoms can be confused with seasickness or alcohol intoxication. Inhaling very high levels or inhaling low levels for a long time can cause death.

Some of the situations in and around your boat that can allow CO to accumulate include:

- Inadequately ventilated enclosures. This can occur in canvas enclosures or in other compartments on board.
- Slow speeds or idling. Exhaust fumes may not dissipate in the same manner as when you are cruising or at fast speed. Also, CO will remain around your boat after the

engine is stopped. It takes time to dissipate.

- Back-drafting or the “station wagon effect”
- Exhaust from another vessel. When tied up at a dock or when rafting, exhaust from another boat may drift toward your boat and into your cabins.
- Swimming near or under the back deck or swim platform when the engine is idling and shortly after it has stopped.

Steps you can take to reduce the risk of CO poisoning include:

- Make sure you and your passengers know where and how CO may accumulate in and around your boat and that they are aware of what early poisoning signs are.
- Maintain fresh air circulation throughout the boat at all times.
- Although CO can be present without the smell of exhaust fumes, if you smell exhaust fumes, CO is also present. Take immediate action to dissipate these fumes.
- Ensure that your engine, generators and exhaust system are well maintained.
- When towing someone, make sure they are at least 20 feet back. Testing has shown that CO remains at dangerous levels near the water surface through this distance.
- “Teak Surfing” is especially dangerous. When an individual holds on to the swim platform, they can inhale carbon monoxide and are dangerously close to the boat’s propeller, which is compounded by failing to wear a life jacket.

## RENDEZVOUS NEWS

### *July 21, 2007 Rendezvous*

On Saturday, July 21, 2007, members of the Squadron met at the Steel Pier in Lake George to enjoy a special ride aboard the PV *Mohican*. The weather was perfect, with beautiful sunny skies, temperatures in the 70's, and twenty mile visibility and calm winds.

Each Squadron member was given a metal medallion commissioned by the Lake George Steamboat Company to commemorate the 100<sup>th</sup> anniversary of the *Mohican's* service on Lake George. Built in 1907, she has been steaming the lake since 1908.

Greeting us aboard, Captain Edward Stanilka thanked the Squadron for our service to the boating community, and related how he still refers to a dated Lake George Power Squadron chart of Lake George which he retained after years of service aboard the old

*Ticonderoga*. He also requested (and the Commander quickly offered!) a copy of the soon-to-be released new chart of the lake, currently being worked on in committee.

Having fun with our being aboard, Captain Stanilka varied the *Mohican's* route on the Paradise Bay Cruise, making frequent course and speed changes to negotiate a sailboat regatta off the lake George Club, passing close by the Sagamore Hotel, running the big boat through the narrow Turtle Island passage north into the Narrows, then southeast past Oahu Island.

During the entire voyage, I had my laptop running Maptech's Terrain Navigator software displaying real-time GPS position data as we sailed. Perhaps one day we might make available our new chart in this increasingly popular electronic format (for a profit, of course!). My thanks to William Dow, who graciously arranged for me to have AC power for my computer.

All in all, my data shows we cruised 29.58 miles on our trip, and great fun was had by all hands.

### *October 21, 2007 Rendezvous*

On Sunday, October 21, members of the Squadron gathered at the Queensbury Hotel for a brunch and presentation by the Lake George Association.

In keeping with our recognition of sixty years' service to boating in the Lake George area, and the Squadron's anticipated introduction of a major revision to its navigational chart of Lake George, Randy Rath of the LGA gave us a presentation covering a wide range of historical and current activities carried out by the LGA and the LGPS.

Randy has been serving as a member of the Squadron's Chart Committee and has also been named an Honorary Member of the Squadron for his service. Randy reviewed the long

history of aids to navigation on Lake George, first installed and maintained by the LGA over 100 years ago. The buoy system later came under the jurisdiction of the DEC, who maintains the system through today.

Randy went on to explain how the various agencies and organizations interested in safe navigation of the lake have contributed resources and data to the committee which enabled this new, much improved chart. He was also able to explain to the members how the Committee has used satellite photos, aerial photography and GPS data to vastly improve the accuracy of the chart.

The Lake George Association is also very actively involved in lake saving projects, and Randy discussed several significant projects aimed at reducing storm water runoff sedimentation of the lake in both the northern and southern basins. Randy pointed out that educating people on the importance of protecting the lake's future is vital, and discussed the many educational and participatory programs for both young and old supported by the LGA.

Commander McCarthy called the meeting to order at 19:11.

**EXECUTIVE OFFICER'S REPORT:**

- Lt/C Londynsky has apparently spoken with the media about our anniversary. A photographer from the Glens Falls Post Star is available to cover the meeting; however, it is being requested that he be provided with a meal. Discussion ensued and a motion was made to affect same. Motion passed.

**SECRETARY'S REPORT:**

1. The minutes from the July 18, 2007 meeting were approved as presented. Commander McCarthy indicated that they "looked good."
2. The Secretary offered to prepare an article for the *Soundings* about his experiences aboard a Maine windjammer cruise, if the editors thought it would be of interest. The editors encouraged the secretary to do so.

**TREASURER'S REPORT:**

Furthermore, the security surrounding the NOAA website will apparently be tightened.
3. The Albany Institute of History and Art, where we enjoyed an earlier meeting and tour of the current steamboat exhibit, is offering a lecture tomorrow about steamboats.
4. A Tri-Squadron rendezvous takes place on Saturday, August 25<sup>th</sup> at a pavilion along the Great Sacandaga Lake from 10 a.m. until 7 p.m. There is a cost of \$6 to enter the park. Please bring a dish to pass. Boat rides will be available. Contact Commander McCarthy for more information.
5. The D-2 fall conference takes place in Danbury, Connecticut on October 12-13.
6. Get your reservations in now for the 60<sup>th</sup> anniversary party and talk it up.
7. Thanks to Admin. Officer Stephen Traver for a very nice cruise on the Mohegan, which took a different route than usual, affording Squadron travelers a glance at unusual Lake George sights. Watch for an article in the *Soundings*.

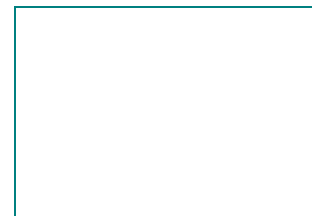
